POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON FRIDAY, 11 JUNE 2021 AND DECLARATION OF FINAL DIVIDEND

The Board is pleased to announce that all the Resolutions were duly passed by the Shareholders by way of poll at the AGM as ordinary resolutions of the Company.

The Board is also pleased to announce that the declaration of the Final Dividend for the year ended 31 December 2020 was approved by the Shareholders at the AGM.

Reference is made to the circular (the “**Circular**”) incorporating a notice of annual general meeting (the “**AGM**”) (the “**AGM Notice**”) both dated 12 May 2021 of Asia Cement (China) Holdings Corporation (the “**Company**”). Unless otherwise defined, capitalized terms used herein shall have the same meaning as those defined in the Circular.

POLL RESULTS OF AGM

The Board is pleased to announce that as more than 50% of the votes were cast in favour of each of the proposed resolutions (the “**Resolutions**”) as set out in the AGM Notice, all the proposed Resolutions were duly passed by the Shareholders by way of poll at the AGM as ordinary resolutions of the Company.

As at the date of the AGM, the total number of Shares in issue was 1,566,851,000, being the total number of Shares entitling the holders to attend and vote for or against the Resolutions at the AGM. There were no Shareholders who were materially interested in any of the Resolutions, and therefore none of the Shareholders were required under the Listing Rules to abstain from voting in respect of the Resolutions at the AGM. There were no Shares entitling the holders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. In addition, no Shareholders have stated their intention in the Circular to vote against or abstain from voting on any of the Resolutions at the AGM.

The Company's Hong Kong branch share registrar, Tricor Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM. The poll results taken at the AGM are as follows:

The relevant exchange rate will be the middle exchange rate of RMB to Hong Kong dollars as announced by the State Administration of Foreign Exchange on the date of the AGM (RMB0.82291 equivalent to HK1.00). The Company would like to advise that the payment of the Final Dividend of the Company is expected to be made on Friday, 25 June 2021.
